Visits for October 1st, 2022 included the following members: Mark Stoeckinger; Seth Fonti; Phillip Cohen; Len Ovsiowitz; Renee Weitzer and Sam Patel.

- 3706 Oceanhill Way the proposed construction was approved providing no roofline modification
- 3749 Malibu Vista Drive modified fence does not cause an OVI
- 3801 Malibu Vista Drive there appears to be an OVI caused by hedge between 3801 and 3809 Malibu Vista Drive
- 18341 Coastline Drive current story poles not approved pending next door neighbor's OVI concerns
- 18409 Kingsport Drive solar panel installation approved pending displaying story poles
- 18444 Coastline Drive proposed construction not approved. Effected neighbors are coordinating a meeting to determine OVI impact

#### **NEW BUSINESS - Seth Fonti**

- Concerns with collecting dues.
  - · Consistency in messaging
  - Understanding low grade enforcement mechanisms
  - What the dues collecting process looks like and where we may need some help.
  - Run a pilot program on the top 50 balances via a soft touch outreach such as a letter from the President or the Board, and or actual engagement with the individual homeowners from the Board members.
  - A collaborative method in communication is desirable regarding dues collection before the annual billing cycle early in the new year.
  - A quote from Don Mink for billing services will be solicited.
  - A digital payment system is convenient.
  - Currently when a home sells and closes escrow it needs to be in good standing. Meaning all back dues need to be paid in order for escrow to close.

### **Update on Flock Cameras and Security**

 Flock camera will be installed in November at the corner of Surfveiw and Coastline.

- Homeowner on property for the Flock camera installation has cleared the area for better visibility.
- ADT's latest rotation and presence seems to be effective.
- Rick Silver has been calling the sheriff's office constantly regarding the illegal RV's and trailers on PCH. More residents are needed to call.
