FIND COVID-19 TESTING SITES WITH THE CALIFORNIA STATE LOCATOR MAP

The State of California has an online, interactive map. Go

to https://www.arcgis.com/apps/Nearby/index.html?appid=43118dc0d5d348d8ab20a81967a15401 for locating COVID-19 testing sites near you. Simply enter a zip code, select the distance (in miles) you wish to search, and the map will provide a list of both State and community testing sites within your specified range.

Public health protocols, including guidelines of physical distancing and the use of cloth face coverings, are in place to help prevent the spread of coronavirus. All beaches, the Malibu Pier, and beach parking lots remain closed, and no-parking zones are enforced on PCH. Residents can report violations of public health and safety orders to the LADPH at 888-700-9995, Monday-Friday, 8:00 AM to 5:00 PM.

WILDFIRE PREPAREDNESS WEEK GUIDE & VIDEO TO GET PREPARED WHILE STAYING HOME. This week is California's Wildfire Preparedness Week, and Listos California and Public Broadcasting Service (PBS) encourage Californians to get prepared for wildfires while staying safe at home. Wildfire is Malibu's number one public safety threat, and fires are not taking time off during the pandemic, so we all must continue the effort toward communitywide preparedness.

The campaign by the Governor's Office of Emergency Services (Cal OES) encourages community members to take these five free-and-easy steps:

- 1. Subscribe for official alerts at malibucity.org (click on E-Notifications on the left-side Webtools menu)
- 2. Make a plan to protect your family by creating an emergency contact list and an evacuation plan.
- 3. Prepare a go-bag with things you need.
- 4. Build a stay box to stay safe at home for when you cannot leave.
- 5. Help friends and neighbors get ready. View or print out the Disaster Ready Guide.
