So you received the L.A. County Emergency Survival Guide, delivered to your doorstep back in July — thank you, volunteer deliverers!

You may have even leafed through it, fully intending to update your emergency preparedness plan and supplies...but, here we are in November, and have we actually taken steps to do so?? Well, if not, there's no time like the present!

This is one in a series of monthly Sunset Mesa-Ge reminders. It is designed to help you avoid being overwhelmed by a bookful of tips, and to focus on one or two key elements of preparation at a time. Granted, fulfilling every one of the book's suggestions, from front to back, right now, might be ideal...(If you have already done so, kudos to you!) The below suggestions are not meant to replace the expanded recommendations in the Guide, but, for we mere mortals, a more pragmatic pace that actually works is certainly better than doing nothing beyond depending on our good intentions to help us through an emergency event!

ach month's to-do list is estimated to take no more than an hour to accomplish. You can come up with one hour a month, can't you? Your safety and comfort upon evacuating may depend on it!

his month's challenge is to begin to put together your evacuation bag, or "Go-Pack". This is a bag or backpack that is always easily accessible, in case you need to leave the house with little advanced notice. You likely already have everything that you need for it at home, so it's just a matter of consolidating items into an easy-to-grab bag. You can always add to it later.

SOME ESSENTIAL EVACUATION BAG ITEMS

(from pg. 20 of your Emergency Survival Guide)

<u>Choose any easy-to-carry bag</u>, for the moment. The size of your bag will ultimately depend on how many household members are likely to be home when you need to evacuate, so you may find that you need something larger, or a second bag, later on, but, for the time being, just use any, old overnight-sized bag that you don't regularly use, into which to toss the following:

<u>*Food*</u> – the idea, here, is to have a few items that you might need until you can get to the home of family or friends, or to an emergency shelter, without

filling a steamer trunk with heavy and bulky provisions! Shoot for three days' worth of provisions. Go to your kitchen cupboards, and grab:

• At least one canned food item times the number of household members likely tom evacuate with you — i.e., 1 can x 5 household members = 5 cans. These can be ready-to-eat meats, stews, fruits, vegetables, etc. —

you may need to eat these cold but better than nothing!

- A can opener
- Snack-sized packets of nuts, dried fruit, peanut butter, granola bars, etc.
- Food for infants, elderly people, or people on special diets
- Food for pets
- Few re-sealing plastic bags (various sizes)
- A small container of liquid bleach to treat drinking water, if necessary,
- Few comfort foods (e.g., instant coffee, tea bags, hard candy)
- Small packets of salt, pepper, sugar.

<u>*Water*</u> – ideally, one gallon per person, for three days. (This probably won't all fit into your bag, but should be adjacent to it.) Whether you carry it in gallon jugs or in smaller bottles, it should be in containers meant for long- term storage (such as purchased plastic bottles, as non-environmentally friendly as that may be...), and in a stock separate from your daily uses, so that it's not depleted when you really need it. Rotate by expiration date.

First Aid Kit – start with the basics. In addition to a 7day supply of your own, essential medications (rotate, as needed), either buy a small, readymade First Aid kit, or go to your home medicine cabinet, and grab

- A variety of bandages, gauze pads/roll, adhesive tape;
- hand washing and/or anti-bacterial towelette packets,
- an extra tube or sample pack of antibiotic ointment (or similar);
- a short list of First Aid instructions (incl. in many kits); and, maybe,
- a small container/sample pack of OTC pain relievers.
- A thin, disposable blanket (the kind that come folded in a ~5 x 5 x 1/2" packet) for each person in the household will be much appreciated, if it gets chilly.

If you have time to be a little more thorough, see pg. 39 of the Guide. There are many items (e.g., scissors, thermometer, sling, instant ice pack) that can be permanently kept in your go pack, because, remember, they will still be accessible by you, at home, unless and until you need to evacuate.

here, you did it! You now have a core part of your evacuation kit, ready to go! Your bag may contain some items that could be dangerous for some members of your household, so keep it someplace safe.

ext month: A few more practical and comfort items for your grab bag, including a list of things to add at the last minute – e.g., cell phone.
