

President's Message by H. Gould, Vice President -

As this year comes to an end, the SMPOA board wishes everyone a safe, healthy, and prosperous New Year. Please know that your board of dedicated volunteers works tirelessly to preserve the quality of life we all enjoy living in one of the most beautiful parts of Southern California. We wish our President Jon Cherkas a speedy recovery and look forward to having him assume his duties early next year. In addition, we welcome Rachel Klein and Seth Fonti as new members to the Board and embrace the new energy they bring to our group.

As of January 1, 2022, a state law SB1388 passed in 2016 meant to reduce "greenhouse" gas emissions goes into effect. To eliminate methane gas that accumulates in traditional landfills which can be 80 times more toxic than carbon dioxide, organic materials will need to be separated into the green bins we currently use for lawn and garden trimmings, and leaves. Organic waste refers to food waste (including vegetable and fruit scraps, eggshells, meat, dairy, bones, and rotting food), foodsoiled paper, (including pizza boxes, coffee filters, and paper napkins) and yard trimmings. These items will no longer be allowed in the black or brown bins.

As we enter 2022 your Board wants to reiterate the requirement to obtain Architectural Committee approval before construction and remodel work begins. Our diligent AC members give their time the first Saturday morning of every month to perform site visits and issue determinations. Think about getting involved and joining the AC team. It is a wonderful way to learn about the neighborhood, meet your neighbors, and contribute. Contact www.sunsetmesaac.com to volunteer. Members in good standing can use this email to schedule a site visit for the following month. All reviews require story pole delineation of proposed structural designs along with Architectural plans.

- A decrease in Banc of CA ending balance, from M/E October, as Debits exceeded Credits.
- Stifel portfolio with a M/E value of \$365,976.20:
 - *Net Cash Equivalents* of \$59,220.05 (16.18%): an increase from M/E October (\$54,026.39) due to

assets sold / redeemed (\$30,000), assets bought (-\$26,181.00) & income/distribution (\$1,375.49).

Credits, Debits and Net Operating Income -

For this M/E November reporting period, 6 Credits (Mesa-Ge Advertisements, Past Dues, Close of Escrows) and 7 Debits were posted to the BCA business checking account as shown in the Summary table.

A negative SMPOA net operating income for M/E November — due to Debits far exceeding Credits driven mainly by excessive legal fees, and a small positive change in Stifel portfolio value.

- YOUR EVACUATION BAG (PART II) -

Last month, we spent about an hour putting together the basics of our go-packs, containing the items that each of us will want to take with us, should we need to quickly leave the Mesa, due to threat by wildfire or other disaster.

You did start to fill your bag, didn't you...? No?? O.K., well, you got lucky, last month...Santa Ana winds led to no electricity on Thanksgiving, but not to our needing to run for our lives; crisis averted. Now, you have another chance – and the motivation – to properly prepare!

Please review the suggestions in the previous Sunset Mesa-Ge for a bag into which to consolidate at least minimal amounts of food, water and First Aid supplies (including personal medications).

TO REVIEW, SEE:

- Your November Sunset Mesa-Ge issue;
- L.A. County's Emergency Survival Guide, delivered to your door in July; or
- The "*Emergency Preparedness*" page for links from a variety of sources: *www.sunsetmesa.org->Bulletins*

Do you need a little time to catch up? Go ahead.....I can wait.

w, we need to take our preparation to the next step. Here is December's list of items. Again, give it an hour, to make real progress! If you're feeling swamped, at the moment, due to the holidays, mark your calendar (right now!) to make it a priority over New Year's weekend. Surely, you can collect a few things from around the house and watch football, at the same time!

ADD TO YOUR GO-KIT THE FOLLOWING:

- Some new good-quality, well-fitting surgical masks, for both air-quality and Covid-related protection;
- A hand-crank or battery-powered radio (with extra batteries, if the latter), because we may not have cellular/internet service;
- One or more flashlights (with extra batteries), because you are not going to want to use what precious power your phone has to light your way;
- Photocopies of each household member's driver's license, passport, Social Security card, medical insurance/Medicare card, Covid vaccination card, VA benefits card, disability placard, and any other record that is especially important to your daily life;
- Photocopies of homeowners insurance;
- An old-fashioned, hard-copy list of out-of-state contacts. While local phone lines may be down, nationwide lines will likely not be, so think of threepeople outside of California through whom you

and your loved ones can communicate your whereabouts;

- A few family photos, for morale-boosting purposes.
- Here are some other supplies that you may need, if applicable:
 - Baby care diapers, formula, food, change of clothing.
 - Pet care food, extra water, bowl, copies of ID and immunization records.

LAST-MINUTE ITEMS TO GRAB WHEN YOU GO.

There are some items that you will definitely want to take with you, but which you use, every day, so cannot pack until you need to evacuate. These include:

- Your cell phone! Bring your electric charger, in case you can use it, and a [charged] portable charger or power bank, in case you can't;
- Credit cards, in case you can use them, and cash, in case you can't;
- Your physical driver's license, passport, Social Security card, medical insurance/Medicare card(s) and Covid vaccination card;
- Laptops and smaller devices, chargers, and hard-drive back-ups;
- Special needs items, such as a pet carrier/cage, muzzle and leash; baby carrier/stroller; wheelchair, walker, cane, hearing aids (extra batteries), personal medications, parking placard.

Some of these necessary items are stored in your wallet or purse, every day...so don't forget to take your purse! Others, you do not carry around, on a regular basis, but will need to quickly access, in an emergency evacuation. Keep them handy, and in one place, with, at a minimum, photocopies always stored in your go-kit. You'll be glad, if it saves you the hassle of having to replace them at an already stressful time.

Done? Give yourself a pat on the back! 🚫
